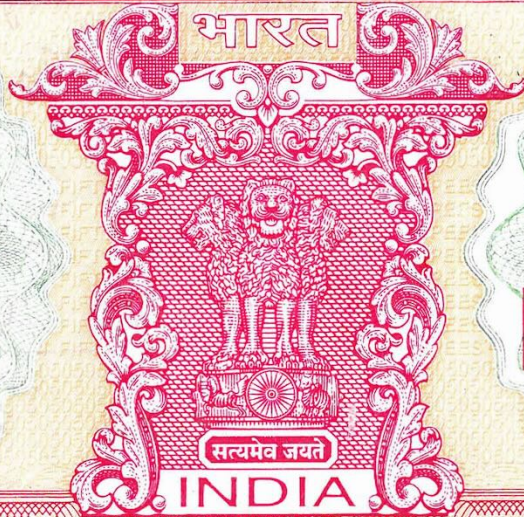

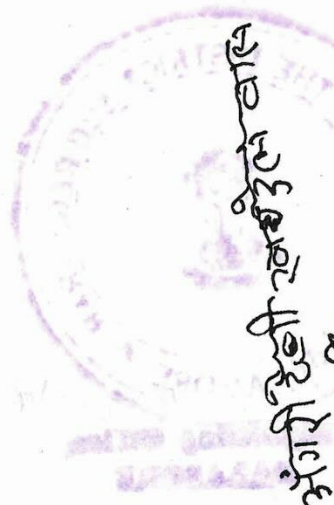

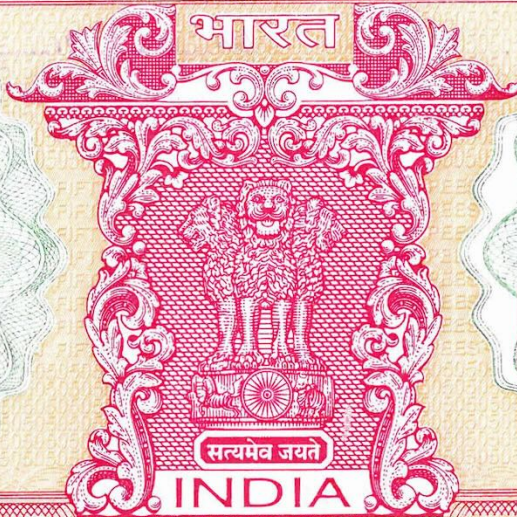

The Trustee may if so desires, resign his Trusteeship even before the expiry of the term of his Trusteeship.

POWERS AND DUTIES OF THE BOARD OF TRUSTEES

- (a) The Trust may receive donations of money or properties; when received shall be at the absolute disposal of the Trust.
- (b) The Trustees shall invest the properties and monies of the Trust in such a manner as prescribed under section-II of the Income Tax Act, 1961 and statutory laws.
- (c) The Board of Trustees shall meet as often as necessary and their proceedings shall be recorded regularly in the minute's book to be retained for the purpose. In any resolution to be passed touching the administration of the Trust, the opinion of the majority shall prevail. It shall be competent however for the Trustees to decide matters by circulation. In case there being equality of votes, the Chairman of the meeting has casting vote for power of deciding the issue.
- (d) The Board may by resolution extend the activities of the Trust to undertake any activity in furtherance of the main objects of the Trust.
- (e) Proper book of accounts shall be maintained by the Trust and shall be audited by Chartered Accountant.

- (f) To do such other lawful things as are incidental in carrying out the administration and management of the Trust.

- (o) On 31st day of March every year a general account shall be taken of all the assets and liabilities of the Trust and an income an expenditure accounts for the whole year and a Balance Sheet as on 31st March shall be prepared and shall be passed by the Trustees. The accounts of the Trust shall be audited annually by a Chartered accountant appointed by the Trustees for the purposes.
- (p) The Board of Trustee shall have the power to acquire immovable or movable properties for the Trust and likewise the power to sell to lease or mortgage or otherwise deal with such properties.
- (q) Any question arising in the administration of the Trust shall be decided by majority of the Trustees acting for the time being.

- (v) The Trustees shall keep an account/accounts with any Nationalized Bank or Banks and to operate such account or accounts whether in debit or in credit and to give all appropriate instructions to the banker or bankers concerning the mode of operation of such account or accounts and to authorize by appropriate direction on resolution of the Trust to any one Trustee jointly with another Trustee to operate such account or accounts.
